- Sub: Regarding Tariff payable to consumers for Net Metering and Net Billing arrangement under RERC Grid Interactive Distributed Renewable Energy Generating Systems.

The Detailed guidelines & procedure for Net Metering and Net Billing under RERC (Grid Interactive Distributed Renewable Energy Generating Systems) were issued vide Comml Aj 841 dt 23.09.2021, further amendment has been issued vide Comml Aj 911 dt 21.11.2023 under which guidelines are mentioned regarding tariff payable to consumers for Net Metering and Net Billing arrangement.

The tariff payable to consumers of domestic category for Net Metering and all consumers under Net billing arrangement was issued vide Comml Aj 876 dt 01.11.2022. Consequent upon amendment in (Grid Interactive Distributed Renewable Energy Generating Systems) (First Amendment) Regulations, 2023 the Tariff payable to consumers of domestic category for Net Metering and all consumers under Net Billing arrangement is revised as under:-

Net Billing:- Rs 3.04 / KWH, it should be applicable for the entire duration of the agreement.

Net Metering:- Rs 2.71 / KWH, this is also applicable in case of domestic category consumer having existing Net Metering connection governed as per RERC (Net Metering) Regulations 2015 and subsequent amendment thereof.

These rates shall be applicable till revised by any order.
